PLENTY OF TIME.

No doubt Ald. Moore in moving at the city council for an immediate vote for the exhibition, was prompted by worthy convictions, but his action seems to have been unnecessary, in view of the resolution which the council had just passed, viz., to apply for legislation to give the city authority to assess for the amount asked by the exhibition management. Ald. Farrell's contention that the council at present has no authority to vote the amount was correct, and his opinion was borne out by the city clerk. The step that the council has already taken must be satisfactory to the exhibition management. First secure the legislation necessary, make the assessment, and then vote the amount. That is the natural and legal order of events, and we have no doubt the council, following the bent of public feeling, will vote the money when the proper time arrives.

DEFEAT FOR PROHIBITION.

The partisans of prohibition will be disappointed by Tuesday's vote in Vermont. The State has had a prohibitory law for half a century, but has finally discarded it for a system of local option. The small towns and rural districts gave prohibition majorities but the large cities went strongly the other way.

The new law, which is apparently on the lines of our Scott Act, goes into force March 1—that is prohibition ends on that date, and the municipalities may then vote whether or not they will have liquor sold in the territory covered by their respective governments.

The Record Foundry and Machine Company of Moncton is one of Canada's most flourishing industrial institutions. It has declared a 10 per cent dividend for the past year, and is enlarging its capital stock to \$1,000,000, four times the present amount. The company already employs 250 hands, but will largely increase the number.

They have a new semi-tetotal society in England, the members of which pledge themselves not to drink between meals. There is nothing in the bye-laws however preventing a man from getting as full as a lord at his meals, and if he does that, there would probably be no desire or capacity for him to imbibe between meals.

A large circle of friends will deeply sympathize with Hon. Charles Burpee in the loss of his estimable wife whose death occurred Tuesday morning at her home in Sheffield, Sunbury Co., after a short illness from pneumonia.

Mr. A. W. Ebbett barrister of Gagetown has purchased the Queen's county Gazette, and it is said will make it a political paper, supporting the local government and the Liberals at Ottawa.

Edmundston has a newspaper, the Times, the first issue of which was issued last week. The editor and proprietor is Mr. A. K. Martin.

THE GOODSPEED CASE.

Further Argument in the Matter—Judge. ment Reserved.

After our report of the argument in the Goodspeed case closed yesterday, Judge Gregory said he thought that the point involved was, whether or not the chairman of the governing board could revise the sentence of the court, which was something the court itself did not have the power to do.

Mr. Skinner said the strongest objection urged against receiving Goodspeed into

the institution was that he would be there for the 39 months, with practically nothing to do, and his evil influence would be exercised over the other boys.

Judge Gregory was of the opinion that the boy should not have been sentenced to the reformatory, but that was not the point involved. The question now is one of conflicting authority.

Mr. Skinner's contention that the act empowering a judge to sentence boys to a reformatory was ultra vires of the dominion parliament, elicited expressions of disapproval from all the judges except Judge Landry, who remained silent during the rather animated discussion between counsel and bench. The judges expressed the opinion that the dominion parliament was all powerful and could legislate as it saw fit on such matters.

In conclusion, Mr. Skinner cited a number of cases in support of his contention that the rule should be discharged. The reformatory came in for considerable discussion, and surprise was expressed by several of the judges that it was without facilities for giving boys an industrial training.

The attorney general, in answer to the statement by Mr. Skinner that the governing board had been shocked when they learned that Goodspeed had been sentenced to the reformatory, said that he had ample opportunity to watch Goodspeed's conduct from the beginning to the end of his examination, and he believed that while the boy had fallen into vile ways, his confession was absolutely the truth.

Chief Justice Tuck—"I arrived at the same conclusion."

The attorney-general continuing, said that as a crown officer he had felt that he was justified in submitting Goodspeed's testimony to the jury as testimony that could be relied upon. He believed that Goodspeed was in no way responsible for the death of Doherty, that he was not an accessory, but had been prevented from fear of his life from informing on Higgins. The fact that Goodspeed confessed to stealing proved that it was in his mind to make a clean breast of everything and give the crown the benefit of his testimony, and he did this without any inducement being held out to him.

Doctor Pogsley was rather inclined to the opinion that those who opposed Goodspeed's admission to the reformatory looked upon him as an accessory before the fact. Rightly or wrongly it was his belief from the evidence and he proposed to act from that standpoint that Goodspeed was no party to the murder of Doherty. Therefore he was not prepared to question the wisdom of the action of the chief justice in sentencing him to the reformatory instead of the penitentiary.

In reply to Judge Landry, the attorney general stated that while in Ottawa recently, he had waited upon the minister of justice and had suggested that an amendment be made to the act to provide that in future boys could be transferred from reformatories to penitentiaries. He had every reason to believe that the change would be made.

At the conclusion of the attorney-general's remarks, the chief justice announced that the court would consider and deliver judgment later in the term.

Judging from the tone of the observation made by the judges while the case was being argued, there seems to be little doubt that the judgment of the court will be against Mr. Skinner and Mayor White.
