A REMARKABLE GAME.

Neither the Mullane-Gumbert nor the Waddell-Young battle can claim the honor of being "the longest ball game ever played." Almost a year before the Cincinnati Fargo and Grand Forks, in Devil's Lake, N. D., fought out twenty-five innings to a nothing-nothing tie, with only twenty-six hits in a total of 191 turns at bat, and with only eleven out of 220 fielding chances refused, one of which was a bungle by a backstop, says a New York writer.

This remarkable game might have gone thirty rounds had not Umpire Walker called it to let the teams catch a train. It was seen by what for that region was a large crowd, and excitement was at fever heat from the fall of the flag. It's most remarkable feature, of course, was that not a single man got around in all those twenty-five innings.

PITCHER POWELL SOLD.

New York, September 13.—"Jack" Powell has pitched his last game for the Greater New Yorks, says the Times. The big pitcher has been sold to the St. Louis club of the American League, the club from which Griffith secured him. An effort was made to effect a deal with two or three clubs whereby a good player could be secured in exchange for Powell, but the St. Louis management needed him badly and refused to waive its claim.

The selling of Powell will not diminish the pitching staff in numbers for Manager Griffith has secured Jimmy Whalen, one of the best pitchers in the Pacific Coast League.

THE HALIFAX RACES.

Will-be-Sure First in 2.22 Class and Lady Patton in the 2.30.

Halifax, N. S., Sept. 16.—The events pulled off on the exhibition track yesterday were the 2.22 trot and pace and the 2.30 trot and pace. The track and the weather were perfect and the spectators saw some splendid racing. The purse for each class was four hundred dollars.

In the 2.22 class, Will-be-Sure, a Springhill horse, took first money. Sleepy Jack second money, May Parkside third money, and Will Patch fourth money. In the 2.30 trot and pace, Lady Patton, the Springhill mare, took first money, Kremella second, Etta Mack third, and Little Mack fourth.

Kremella in the 2.30 class reduced his record from 2.29, made the first day of the race meeting, to 2.22½. May Parkside proved herself a good one. The summaries:

HORSES RETIRED.

New York, Sept. 9.—Three famous horses, James R. Keene's Wild Mint, by Kingston—Mint Cake; John A. Drake's Opt Wells, by King Eric; Tea's Over, and E. R. Thomas' Reliable, by Watercress—Arnette, have wound up their turf careers for all time, according to present indications. Wild Mint, while taking the usual morning gallop yesterday, broke down badly and will not race again this year, and may be retired permanently.

Ort Wells in a trial on Wednesday, also broke down in such hopeless fashion that Mr. Drake said yesterday that the great horse could never stand training again.

Reliable, who has not raced this year, and was recently sold by Mr. Thomas to J. B. Haggin, was loaded on the cars last night and sent to Elmendorf Stud.

THE RING.

GRANEY'S DECISION WAS PROPER.

Referee Graneley declared all bets off before the fight between Britt and Battling Nelson began. Certain young, hysterical writers are trying to prove that Graneley had no right to make such a decision because there is nothing in the rules to cover the point, says A. H. C. Mitchell. Is there anything in the rules that says a referee has a right to examine the gloves of a contestant? Yet who would say he had overstepped his authority if he threw out a pair of gloves in which he found a couple of horseshoes?

Did Grant have a right to cut wire communication with Washington when he plunged into the Vicksburg campaign? Was there anything in the rules that gave the President a right to "butt in" on the Portsmouth peace conference when things looked darkest for a peace outlook?

The Boston American upholds Graneley's decision. So do all experienced fight writers throughout the country. No matter whether Graneley had the "right" to declare all bets off or not. He called them off, and that's all there is to it. Under the circumstances it was the proper thing to do. No one is losing any money over the decision. Many persons may have failed to win a bet, but it has cost them nothing.

Of course, there are two sides to the question, and it is not to be expected that those who bet on Nelson will agree with Graneley's ruling. W. W. Naughton, the foremost writer in the world on pugilistic affairs, upholds Graneley. So does Robert Edgren, sporting editor of the New York Evening World, a man of vast experience in ring affairs.

Here is what Cartoonist Tad of the Boston American staff, says concerning Graneley's decision: "Eddie Graneley has received all sorts of roasts for calling bets off in this fight, but there are two ways of looking at it. One Nelson man last night said that the Britt men, seeing their sure-thing chances gone, demanded that Graneley declare all bets off and save their money, but this is hardly fair to the little blacksmith.

"The most plausible argument it seems is this:

"Graneley was in two very queer looking fights out there and although he acted honestly his decisions were taken as bad. When he declared Britt the winner over Young Corbett Graneley's best friends lost thousands, I know of three prominent Frisco sports, two companions of Graneley, who lost large wads, but Graneley probably did what was right in his mind.

"He also refereed the Britt-Gans farce, and although he had nothing to do with the deal, as they claim it was, he was in the ring, and it looked bad.

"Now, when Billy Nolan agreed to Graneley, there were probably thousands who expected another crooked thing, and in order to clear his name of all friends he declared the bets off. Whether he had the right to do this before the men even shook hands is still a question, but it happened. His it's all off."

Bob Edgren, sporting editor of the New York World, has this to say regarding the decision of Graneley: "Graneley, in calling off all bets, on the fight, did the right thing. 'All,' of course, includes bets on the number of rounds. There is only one possible exception. Bets should be paid when it was previously agreed to let the wager stand, whatever happened.

"He had a right to call the bets off. There is no written rule of the prize ring governing the matter, but his right is recognized by custom. It is desirable that men who bet should have this protection, and Graneley had good and sufficient reasons for calling bets off, as many sporting men would not believe that he could referee without prejudice."

Patsy Sheppard, however, who so successfully steered John L. Sullivan to the heavyweight championship, says that Graneley had no right to declare bets off before the fight. This is what Patsy thinks about the matter:

"I don't think Graneley had any right to call bets off until he saw that things were going wrong. It was a fair, square fight, and the best man won and those who bet their money on Nelson should be allowed to cash in. If the fight had proven a fake after the start, then Graneley should have called matters off, but not until he did see or think things were going wrong. At that, I had a little bit of the long green on Britt."

"If I had bet on Britt with a book maker," said Denny Kelleher, "I'd stand by Graneley's decision, but if I'd made a bet with a friend that Britt would win I'd pay it. That's the way I think about this matter."

Tom McCarthy says that Graneley had a right to call matters off, as he wanted to protect everybody. He knew that bets had been made with the understanding that efforts was to be the third man in the ring.

Miah Murray says:

"Graneley's decision goes with me. That's all."

YACHTING.

LIPTON READY TO CHALLENGE AGAIN.

Sir Thomas Lipton recently arrived on the Clyde on his steam yacht Erin, and at once the rumor spread that he had gone there to make arrangements for the building of another challenger for the America's Cup. The Yachting world representative Sir Thomas, I was assured that the visit had no direct

bearing upon the international contest. Sir Thomas Lipton admitted, however, that his desire for the reopening of the contest was as great as ever, and stated that the matter remained at a standstill only because the leading designers of Britain had declined to further prosecute the challenge under the old conditions and the old rule of rating, and the New York Yacht Club meanwhile showed little disposition to alter either.

"He mentioned that he had written personally to the secretary of the New York club asking whether a challenge to be sailed under the new rule rating adopted by the club would be accepted. The reply to that communication was such as to make it necessary for him to proceed with the challenge before the matter could be considered. Sir Thomas added that he had no desire to put forward a challenge which he might afterwards find himself unable to carry through. He added, however, that the American press was arguing in favor of a revival of the conditions of this contest, and he had hopes that the defenders would eventually agree to conditions more fair for the challenging vessel."

Forest and Stream of September 9 had this to say about the America's Cup and the new rule: "The New York Yacht Club has now at hand a rare opportunity to declare itself unequivocally in favor of the new rule. A definite statement to the effect that under it all future contests for the America's Cup shall be sailed would be taken by the world as a final stamp of approval. Continued silence on the subject will be construed as a lack of confidence in regulations which have been adopted in good faith by the leading yachting organizations of the country. Not until the new rule is applied to the blue ribbon contest of the seas will foreigners and many of us at home believe that any profound convictions as to its efficiency exist."

"It is not pleasing to contemplate the deadening effect on enthusiasm now prevalent which another international series held under the old conditions would have. Yachtsmen would be called upon to view the spectacle of intelligent men fostering an event previously declared radically wrong. If the new method of obtaining racing length is worthy of unflinching support, it is certainly suited to govern any contest of any degree of greatness, wherever held. The rejuvenating effect which would result from the introduction of a more healthy type of boat in races for the America's Cup has never been questioned. It would open for future competitors a channel to possible success and no doubt bring closer contests than have resulted under old conditions. It would also provide a medium by which the rule would be put to the test in no uncertain manner. Weak points, if they existed, would be brought to light and a worldwide lesson in type development follow. It seems to be a question of only a short time when the desired declaration must be made, unless the custodians of the Cup are willing to go on record as considering the new rule still in experimental stages. No move at the present time would bring greater satisfaction to the yachting world than a final clearing up of the Cup situation."

BOWLING.

PROPER SPOTTING OF PINS.

Henry Fallick, a well known Brooklyn bowler, has patented an electrical device intended to settle once for all the mooted question as to whether the pins are properly spotted.

The invention consists of a board studded with electric lights arranged in the shape of a pyramid, which is placed directly over the pins. The latter are provided with iron points and when they are properly spotted all the lights in the board flare up. If one pin is off the spot the 'a' series of the light informs the bowler that such is the case. At the same time the contrivance informs the scorer how many pins are down. It has not been generally adopted as yet.

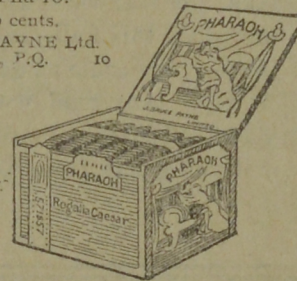

RASCALLY BROKER

Boston Man Arrested for Fleecing Parties out of \$75,000.

Boston, Sept. 15.—Harry Clifford Brown, a stock broker of this city, and a well known resident of Brookline, was arrested yesterday by inspectors from the Boston bureau of criminal investigation on a charge of forgery. According to Chief Inspector William Watts, numerous trust companies, other corporations and individuals claim to have lost seventy-five thousand dollars through transactions with Brown.

The charges upon which the broker was taken into custody were those of raising two certificates, each representing one share of the Boston & Albany Railroad Company, to 20 shares, and issuing the certificates as security on notes, upon which Brown is alleged to have obtained seventeen thousand dollars from the Washington Trust Company.

The complaint states that on June 19, a certificate, raised from one share to 20 shares was deposited at

the Washington Trust Company as security, and that Brown obtained four thousand dollars. It is also alleged that four thousand dollars was paid by the trust company to the broker on a similar certificate on April 28 last.

Chief Watts is still investigating the charges which have been made against Brown and it is said further developments are expected.

Brown is forty-five years of age and resides at thirty, Naples Road, in the fashionable section of Brookline. He is a member of several clubs.

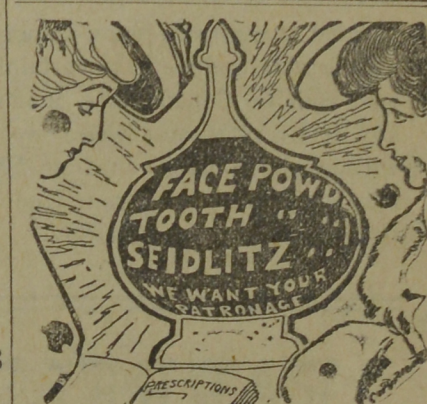
