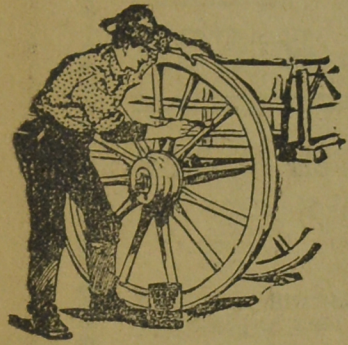

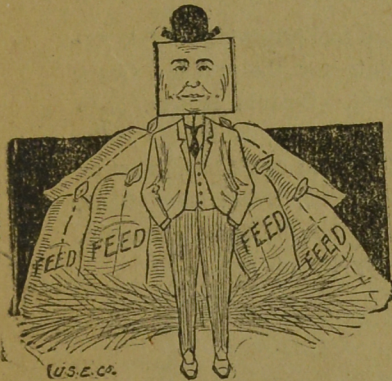

HE DOESN'T FORGET.

Frederick W. Story of Baltimore Has a Wonderful Memory.

Those who know Frederick W. Story, the Baltimore lawyer, do not regard it as remarkable, says the Baltimore Sun, that he was able to reproduce from memory the will of his mother, Mrs. Elizabeth B. Story, who died some years ago.

Mr. Story wrote the will from his recollections of it after having read the document, and his draft has been sent to the probate court of Middlesex county, Mass., to be set up in lieu of the original will, which has been lost.

His associates in the city solicitor's office frequently call upon him for a name or a date, and he has scarcely been known to fail to give the desired information. Some of those who know him say he never forgets anything he reads or sees. He has at his fingers' ends all the important decisions of the court of appeals and can mention the title of any case in which a point that may be at issue has been decided.

He admits that he may have forgotten some things, but he can repeat the name of every member of the house of Plantagenet, the names of the kings and queens of England and France and the rulers of many other countries, with the dates and duration of their terms. He can repeat also the names of the presidents of the United States with the years in which they served, but he says every one should be able to do that.

Although he has, of course, not been at school for years, he can repeat pages of Virgil and Homer, and probably could repeat nearly the entire Book of Common Prayer of the Episcopal church, of which he is a ward.

Mr. Story is a student of genealogy and history and has a vast fund of information on those subjects. From memory he can draw the map of almost any country on the globe. When he was five years old he started to school, and the first day he was promoted to the first class, but was put back because of his lack of knowledge of geography. The lack he has since supplied. He continued at school until he was graduated

from Harvard. Mr. Story is a son of the late Judge Isaac Story of Massachusetts and comes of a brainy family.

Clothes in New York.

The hired designers, the fitters, the needlewomen do the rest. And the bill comes in, \$30 to \$150 for a hat, \$300 to \$2,500 for a gown. There are plenty of prices like that in New York. Then there are others that gently let you down, down until you strike prevailing rock bottom at about \$15 for only the making of a gown and \$25 for a hat that is a hat.—Broadway Magazine.

POPE'S NEW DECREE.

Relating to Engagements and Mixed Marriages.

Mantreal Star—Last evening in St. Agnes Church, Rev. Father Meloche, who is recognized as one of the most profound Roman Catholic theologians of the arch-diocese, expounded and explained the new decree of the Vatican, on matrimony and engagements.

The church was taxed to its full capacity by the men of the parish.

"We deem it advisable," began Father Meloche, "to explain to you the new laws on engagements and marriages, which will go into force, after Easter Sunday. The Pope as Sovereign Head of the Catholic Church, which is a perfect society, established by Christ, has the right to make such laws as are conducive to the happiness and well-being of the members of the Catholic Church. This power over the whole church is invested in the Pope alone. A Bishop may make laws for this diocese; a parish priest cannot for his parish. A bishop must not make any laws which run counter to the laws promulgated by the Pope. Circumstances change very much. Discipline may change. Doctrine cannot change. We cannot add or take from the fullness of the doctrine of Christ. The new marriage law is a mere matter of discipline.

ENGAGEMENTS.

"An engagement to be valid must contain the free promise and mutual consent of the two parties. The engagement must be in writing by both parties and signed by the Bishop, or the Vicar-General or the parish priest or two laymen. If one or both of the parties cannot write, this fact is to be noted in the document, and another witness is to be added,

who will sign with the parties already mentioned. So that if bans are already published, and an interested party objects under the plea of a prior engagement. Without these conditions an engagement is null and void.

CATHOLIC MARRIAGES.

"Any parish priest can validly marry a couple from any parish in the world providing he performs the ceremony within the limits of his own parish. He may marry validly in the Church, or in the house, or even in the street. The parish priest would thus marry a couple, neither of them of his parish, sins if he celebrates without the permission of the Bishop, Vicar-General, or the parish priest of one or both of the parties. If one of the parties reside thirty days within a parish, the parish priest of said parish can marry them not only validly, but lawfully, and the ceremony is a real and true marriage.

"A Catholic who has left the Church is held as a Catholic for this particular case. The marriages of Protestants among Protestants the Church leaves alone. She leaves them to their own rules and regulations, and if they should later on enter the Catholic church there will be no question of the validity of their marriage, as far as the presence of the priest is concerned.

MIXED MARRIAGES.

"Mixed marriages are lawful when a parish priest performs within the limits of his parish. To be lawful a dispensation must be obtained from the Bishop.

Her body, dead and with broken ribs and internal injuries was found two hours afterwards in a vacant lot along the five-story house.

FORECAST OF THE BRITISH CABINET.

The London Chronicle Has Announced Premier Asquith's Probable Appointments.

LONDON, April 9—Herbert H. Asquith, who has gone to Biarritz to see King Edward with reference to the formation of a new cabinet will not return to London until next Saturday.

The Daily Chronicle which may be regarded as good authority, gives the following forecast of the probable changes in the Cabinet.

H. H. Asquith—Prime Minister and First Lord of the Treasury.

David Lloyd George—Chancellor of the Exchequer.

Lord Tweedmouth—President of the

Council.

Earl of Crewe—Secretary of State for the Colonies.

Reginald McKenna—First Lord of the Admiralty.

Winston Spencer Churchill—President of the Board of Trade.

Walter Runciman—President of the Board of Education.

KING MAY VISIT AUSTRALIA.

Earl Dudley's Appointment Forerunner of Royal Visit.

LONDON, April 9.—Inner court circles declare that the King's appointment of the Earl of Dudley as Governor-General of Australia is the forerunner of a Royal visit to the antipodes. The King has long wanted to pay a visit to his most distant colony, and Sir Frederick Treves has told him it would do him an incalculable amount of good.

It is asserted that Lord Dudley's principal duty next year will be to make arrangements for the King's visit. Despite this honorable possibility, the Earl of Dudley is very much dissatisfied over his appointment as Governor-General of Australia, although King Edward was personally responsible for his selection. He knew as most of the eligible diplomats know, that the life of an Australian Governor-General does not lie in rose-strewn paths. First of all, the ultra-democratic Australian resents importation of his ruler's representative, and clamors for a home-grown official; and, secondly, he does not understand the panoply of state that surrounds the office.
