## TROOPS CALLED OUT.

### Coal Strike Situation at Glace Bay Takes a Serious Turn.

### MANY DEPREDACTIONS COMMITTED.

GLACE BAY, July 8.—(Special)—Later reports from Dominion No. 6 Colliery, which was closed down on Monday last, and where the U. M. W. are very strong, tell of a number of depredations committed by the strikers there during last night. A number of the men set fire to one shack and tore down a portion of the fence enclosing the colliery, and a gang also broke all the windows in the warehouse and other buildings about the colliery. There were only two or three policemen present, and they could do nothing.

It is also reported that a number of the strikers tore up a portion of the Sydney and Louisburg railway track at Caledonia Junction this morning, and had it not been observed and repaired in time probably one of the coal trains would have been wrecked or derailed.

The reports are contradicted by U. M. W. officers who claim that the company instigated these depredations which are committed by their own men and they blame the strikers for it.

A heavy rain is in progress here at present, and everything is very quiet about the mines. The company claim that they have about 12000 men working.

ALL IS QUIET TODAY.

GLACE BAY, July 8.—(Special)—This morning everything was very quiet at the collieries and no disturbance of any kind occurred. The collieries were thronged with men who congregated around the fences, but made no offer to molest any of the men returning to work this morning. President Dan McDougall and Harry Bonsfield, of the U. M. W., visited the several collieries at six o'clock this morning and addressed the men where they were assembled around the gates, and asked them to maintain order and not use force on men returning to work.

One of the men at No. 6 colliery asked him "can we call the men scabs," and Mr. Bonsfield replied that they should not call the men scabs, and if they wanted to work let them do so without trying to injure them or interfere in any way. It would do them no good and make the matter more difficult for the men themselves.

The collieries of Dominion and reserve are working today though the number at the latter colliery is reported to be greatly reduced.

It was reported last evening that the U. M. W. were about to concentrate their forces at Dominion No. 1 colliery this morning and prevent, if possible, the working of the mine. That, however, was not done and though there was some disturbances this morning when the men were going to work nobody was seriously molested by the strikers, and the colliery is running full time.

The militia, numbering about five hundred, left Halifax at three o'clock this morning, and will arrive here about 2 o'clock this afternoon.

GLACE BAY, July 7.—Before morning a military train will be speeding on its way from Halifax to Cape Breton with a strong force of Canadian Regulars, guns and stores. This is in accordance with a requisition from Judge Finlayson of Sydney, and the decision of the authorities to act upon it.

The most actual violence occurred at No. 3, where there were many assaults but none of a really serious nature and no one was sent to the rear on a stretcher or received dangerous wounds.

Eleven men were arrested at No. 2, charged with riotous and unlawful assembling, all of whom were later admitted to bail, and will be tried on Monday.

As a summing up of today's conditions it is certain that Nos. 3, 4, 6, 7 and 9 pits are out of business. They may run tomorrow, but only time will tell. Official statements given out are most unreliable.

The temper of the men was decidedly better this afternoon than during the forenoon. There was a dangerous feeling in the atmosphere during the early part of the day. A spark, the crack of a pistol shot would have made long regrets or

the community. The storm centres for tomorrow will probably be Dominion Nos. 1 and 4. There are lots of bricks up at No. 4, and it is expected they will be used when the men start to work in the morning. The officials' statement of output by the company today is: Dominion No. 1, 2,200 tons; Reserve, 1,800; Caledonia, 450.

NO NEED OF TROOPS.

Mr. Duggan states that the condition is beyond the control of the civil police, and requests the mayor to apply for military protection. This Mayor Douglas refused to do, and at the same time offers to submit to the council the question of appointing a large number of special police.

Mr. Duggan, when asked tonight if there was anything in the military story, would not deny to affirm the same.

MAKES BIG CLAIMS.

Harry Bonsfield, international organizer of the United Mine Workers, was in the city last evening and discussed the present situation at the collieries, except Nos. 1 and 5, Dominion and Reserve, are wholly tied up and less than 100 men are in the pits at Dominion No. 1 and Reserve. The situation is highly gratifying to us.

"Mr. Moffat's claim in local press that more men would have reported for work but for the interference of the United Mine Workers men, is not well founded. The fact is that former members of the P. W. A. are reporting hourly to the several United Mine Workers locals seeking membership in our organization. The number of men at work, small as that number is, represents in our opinion the total strength of the P.W.A. The maximum of the P.W.A. adherents does not exceed 500. We claim that the numerical strength of the U. M. W. is as we stated it.

PROTESTS AGAINST MILITIA.

On hearing about the coming of the militia, Mayor Douglas of Glace Bay sent the following telegram to the acting minister of militia, Ottawa, and to the commander of the forces at Halifax:

"As Mayor of the town of Glace Bay, I strongly protest against the militia being sent to Glace Bay under the present existing conditions in the town, as I consider that the situation here is not beyond the powers of the civil authorities to suppress or to prevent or deal with as required by Section 8 of the militia act. Further the town council of Glace Bay at its regular meeting to-night endorsed my position by resolution, and I hereby notify you that the town repudiates any expenses or charges on account of or incidental to the sending of the militia and their stay here.

(Sgd.) "John C. Douglas." Judge Finlayson said tonight that in response to affidavits setting forth the deeds of violence which have been committed and the dangerous state of affairs which is anticipated, he signed a requisition for troops from Halifax at 10 o'clock last evening. This was wired to the commanding officer forthwith and the original will be forwarded by mail.

PIERCE ASSAULTS ON MINERS AND OFFICERS.

It was Dominion No. 2 that the U. M. W. continued to mass their greatest strength. Through the night it became manifest that the appeal of the leaders in the strike movement would have its effect, and many feared that the law and orders would be in the morning, surrender to excitement and violence.

As the men who desired to go to work approached the mine at an early hour they found all the approaches surrounded by thousands of excited men, jeering, shouting and otherwise endeavoring to prevent the resumption of work. General Duggan and J. R. L. Ross as well as Superintendent McKenzie and the manager, were all in vain.

Mr. Duggan placed himself at the head of his men and exhorted the strike leaders to break away and at-

The estate was sworn at \$18,900, of which \$6,000 represents real estate and the remainder personal property. Mr. Havelock Coy is proctor for the estate. ## THE CURREY DIVORCE CASE.

### Husband Denies Wife's Allegations and Declares She Neglected her Children.

At the divorce court this morning the Currey case was continued, Dr. L. A. Currey occupying the witness stand. Mr. Teed claimed the witness talked too much when answering questions. Dr. Currey said his wife would often come home late at night, and when he asked her where she had been she replied "None of your business." He repeated his statement about his wife being intimate with the servants and other people. Witness gave an instance a trip which his wife had taken on the steamer from St. John to Eastport. She sat on deck with a man witness considered a blackguard, and she refused to leave the man's company when witness requested her to do so. Witness intended to leave his wife then, but she asked his forgiveness when they reached Eastport. For the sake of the children he decided not to leave. Mr. Currey continuing repeated the evidence given by him at the former trial regarding his wife's neglect of the children, and how she went about St. John trying to injure him with his clients and fellow attorneys. The witness finished his direct evidence, and was taken in hand by Mr. Teed. Shortly after the cross examination had begun, Mr. Hannington received a telegram stating that Mrs. Currey's summer house at Westfield, had been destroyed by fire last night with all its contents. Mrs. Currey, who was in the court, was very much affected by the news. She said that

### PECULIAR CASE.

#### The Case of a Russian who has Lodged in Several Local Institutions.

The Russian who was arrested on Monday for loitering around the Victoria Hospital will be up before the police magistrate tomorrow for examination. The man arrived here in the winter from the Transcontinental Railway works at McGivney's siding and was suffering from a frost bitten foot. He was taken to the Victoria Hospital and when he recovered was placed in the Municipal Home. He left that institution on Monday and returned to the hospital.
