RYAN FOUND GUILTY. Jury Decides That North Bay Man Slew His Brother. North Bay, March 24.—Maurice Ryan was yesterday afternoon found guilty of the charge of having murdered his brother, Joseph Ryan in November, 1907. The jury were out less than half an hour. Sentence was deferred until to-day. The defence practically rested its

case on the testimony of one witness who swore to meeting Francis Joseph Ryan and conversing with him during the February following his disappearance. Link by link Provincial Detective Greer presented a chain of evidence implicating the prisoner, who sat in the box with immovable countenance, betraying no feeling. Justice Latchford's charge to the jury was against the prisoner.

BRIEFS FROM THE WIRES.

Governor Hughes last night signed a bill designating Oct. 12 as a legal holiday, to be known as "Columbus Day." A bill making kidnapping a felony punishable only by death by hanging, has been introduced in the Pennsylvania Senate. Earl Grey announces that the school children of New Zealand has contributed in penny subscriptions to the Quebec battlefields funds the sum of \$950. The Dominion Government will take no action in the present session in regard to the tariff questions raised by the revision in the United States. The Commonwealth Government has decided not to offer a Dreadnought to England, preferring to adhere to her settled policy of defending Australia.

DEBATE WARMING UP.

Messrs. Upham and Tweeddale Contribute Important Speeches.

DAMAGING CHARGES PREFERRED AGAINST THE HAZEN GOVERNMENT.

In the local legislature Wednesday Mr. Upham said he had been forced to take part in the debate by remarks made by the Premier and by the member for Carleton regarding himself. Reflections had been made upon the manner in which he had obtained his seat in this House. He had this to say that he was here as a representative of Carleton county by the will of the people. The Premier had stated that had it not been for a technical error he might not be here. He was not responsible for the stupidity of the Premier and of his party lawyer. It was not adding anything to the prestige of the Premier the way in which he had been used and what had been said about him since he came to this House, and he did not propose to be censured for occupying the seat to which he had been honorably elected. During the debate on December last, everything had been dug up and hauled up in road work, contrary to law, trying to defeat him. He could count seventy odd men who were doing road work during the two elections last fall, all contrary to law, and he considered the money put on those roads as waste. He made the statement on his responsibility as a member of this House that provincial money was spent in Carleton county to obtain results in the Dominion election. Any practical man knows that it is necessary to do road work in the spring, and this had been the practice in this province for generations past, and yet in Carleton county, men were at work on the roads from the 8th or 10th of October until after the 1st day of December. He did not approve of the Highway act of 1904. He wanted to see the best possible road act enacted, irrespective of which side of the House it may come. The people had turned the old government out and down on account of the old Highway act, and the gentlemen who are now in power, when in opposition promised to give the people a new Highway act, but they had not done so, and he held the government responsible before the electors for not having ability enough to give the province the road act which they promised.

Mr. Munro asked if the hon. member did not know John H. Lee, the vendor, sold more school books than any other two stationery stores in the town of Woodstock.

Mr. Upham replied that he did not know any such thing. He did not believe the statement was true. What he objected to, was the principle that respectable and established stationery stores cannot get school books to sell while partizan friends of the government are appointed vendors.

The junior member for Carleton had said that one reason why the government candidate was defeated in that county, was because they had no daily newspaper. He thought the hon. member owed the Daily Gleaner an apology. During the election campaign, the daily Gleaner was brought into the county by hundreds, and given away to everybody who would take it, and the junior member for Carleton gives this as one reason why he (Upham) was elected.

He had already referred to road work being done in Carleton county late in the fall contrary to law, and he wanted to add that this road work was done by days work, although the members of the government had promised when in opposition that they would have all work done by tender or contract. The roads in Carleton county were no better last year than in previous years. As an instance of this he would cite a piece of road that was being built from Newburg Junction to the Hale place. This piece of road was left in a disgraceful condition for six months or more. It was almost impassable.

RAN CLEAN ELECTION.

Regarding the election in Carleton county and the manner in which he had won his seat, he would tell the Premier of this province that no criminals were turned out of gaol to elect him. He was personally free from corruption and clear of censure in that regard, whatever had been done by his supporters, and he would ask the hon. junior member for Carleton if they are equally clear? He would make the statement from his place here in the House that rum, money and other corrupt influences were used to elect the present members for Carleton county who sat on the government side.

Mr. Munro said he repudiated any such statement as the hon. member had just made, and he would ask him to either retract or make good. He had never contributed in any way, shape, or form to corrupt the electors, and he would ask the hon. member (Upham) if he can make the same statement regarding the elections last March?

Mr. Upham said that if what the hon. member had just stated was correct, then he was awfully misrepresented in Carleton county. The present government had turned criminals out of the gaol to try and elect their candidate. On the 28th of May last, one Henry Armstrong, a great friend and worker of the Conservative party, was committed to gaol for theft. On the 26th of Oct. last, he was let out of gaol, taken over the St. John river in a canoe, where he voted, he presumed for the government candidate. Armstrong was then allowed to go to the town of Woodstock in a drunken condition, and he made a remark to a friend with whom he had a drink that he must hurry up and get back home or he would be locked up.

He wished to place himself on record as pleased to hear that some of the school books had been made cheaper. He had heard it said, that the solicitor general, during the election had pledged himself to give the people school books at half price, or else he would resign his seat if elected. School books are not half price, and he had not heard of the resignation of the solicitor general. It was a question whether it would not be better for the government to directly give the people assistance by buying the school books rather than indirectly tax them to make good the losses under the present methods of supplying them. He understood that the books are placed out around the country on commission, and the government is certain to meet with some losses on account. He thought the government should have taken a bond from the store keepers who are allowed to handle these books. In the town of Woodstock there are two respectable stationers who have been in business for years, and he was informed that they had been refused permission to handle the school books, and the proprietor of a five and ten cent store made a vendor.

MR. TWEEDDALE

Member for Victoria, Strikes Out Right from the Shoulder.

Mr. Tweeddale said that the speech from the Throne was more a recital of events than a forecast of proposed legislation. The government had not been able to carry out its pre-election pledges and promises and the people had discovered it and now know that the utterances of the members of the government were mere deception. They promised reform and retrenchment and a new Road Act, neither of which they had been able to keep and the people will have no confidence in their future utterances or promises. The course of some members of the government had been very inconsistent particularly that of the President of the Council on the prohibition question. When in opposition nothing would satisfy him but absolute prohibition, but now he is muzzled on that question. He also advocated retrenchment and succession duties and said the government ought to build steel bridges and pay the bonded indebtedness out of current revenue. Now he is silent.

The speakers, who are apologizing for the short coming and unexecuted pledges of the government say they had not had time. That the government had been busy paying bills of the old government. That statement was false. This government issued bonds to pay off all the old liabilities and they started with a clean sheet, something which no other government ever had done. He wanted a misrepresentation stopped. They promised retrenchment and yet they had voted \$100,000 more for supply than any other government.

Hon. Mr. Morrissey said that he would remind the hon. gentleman that \$79,000 of last year's grant had been spent and anticipated by the old government. The government is still paying bills for 1907. They paid some old bills today.

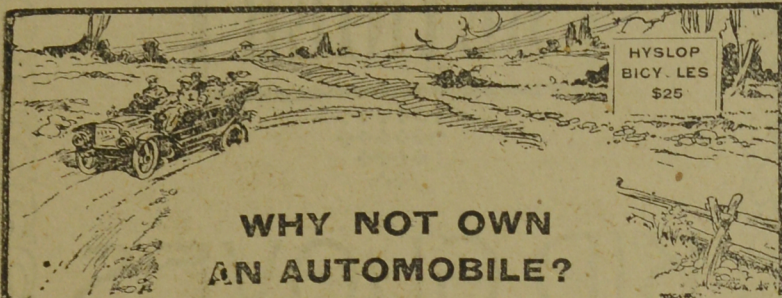
Mr. Tweeddale continuing said that the government had looked after some of their friends pretty well and had rewarded them with public positions dismissing capable officials to make places for them. As an instance he would mention the gentleman who had been appointed Official Reporter of this House and who last year received about four thousand dollars out of the public funds. He got \$1,600 last March for reporting the debates of this House, he will get another \$1,600 this March and in addition will likely get seven or eight hundred dollars for his services on the Agricultural Commission.

Hon. Mr. Hazen said that he presumed the hon. gentleman wished to be fair and if so, he would state that out of the \$1,600 the Official Reporter paid more than one half of it to the Telegraph Co. for tolls and out of the balance he had to publish the debates in book form and furnish 300 copies of same.

Mr. Tweeddale went on to say that Mr. Burgess and himself had accomplished more for the good of Victoria county and for the province at large by one single act, than all these gentlemen put together ever had done or would be able to do for many years to come. They had persuaded the government of the day to purchase fifty thousand acres of settlement land from the New Brunswick Land Company at 75c. per acre and to open these lands for colonization purposes. This year at least \$75,000 worth of lumber will be cut on the Blue Bell Tract alone. The government takes great credit for an increase of ten thousand dollars in stumpage last year, but did this increase of ten thousand dollars in stumpage come from an increase in the price of the province was increased by thirty thousand dollars in purchasing this fifty thousand acres of land and today it is worth five dollars an acre and represents an asset of \$250,000. In accomplishing this one thing he and Mr. Burgess had done more for Victoria county and for the province than any other representatives the county had had for years. Hon. Mr. Pugsley put through the bill authorizing the purchase of this land and in the short time he had been at Ottawa he had secured a subsidy for a railway from Westville to Grand Falls, which will bring this great property into touch with transportation facilities. No great noise has been made about this but if the members of the present government had done half as much you would hear such a noise that one would not be able to sleep. This shows the difference in the calibre and capabilities of men on this side of the house and on the other side. The solicitor general made the statement in Victoria county that there was a mortgage on these lands but he was hardly re-

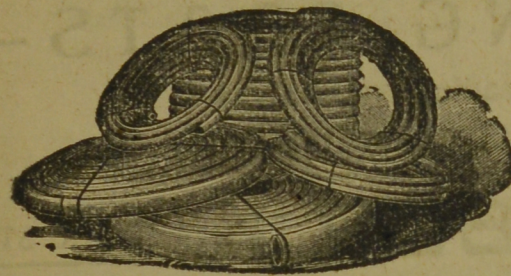
