VERDICT FOR \$2,080 IN JAMIESON CASE

Before Courts Many Times and Apparently Still Unsettled—Stay of Postea Granted.

After being out three hours and a quarter, the seven jurors in the suit of Harris vs. Jamieson, filed into the court room at half past seven last evening, and foreman R. R. Patchell submitted the jury's report to his honor. They found that the plaintiff had suffered loss to the amount of \$2,080.

On the 17th, Mrs. Harris obtained a verdict for \$780. The defendant appealed to Frederickton, applying for a new trial, which was granted. A new trial took place and the jury this time gave \$1,250 damages.

Yesterday afternoon, his honor Judge Landry, concluded his charge to the jury at a quarter past four, submitting three questions for their consideration. This third trial has aroused so little public interest that when Constable Gibbons returned with his charges, no one was in the court but the judge, the defendant and the hungry lawyers and court officials.

In answer to the first question, the jury reported that they found the defendant guilty of negligence. In reply to the second question, they set forth the carelessness shown by the defendant and assessed the damages at \$2,080.

When his honor had found accordingly, he discharged the jurors and the court adjourned sine die.

New York, Aug. 19.—Believing her husband was about to leave her forever, Mrs. Edward H. Hacker, committed suicide today by shooting. Her husband heard the shot and ran back. THE ACADIAN CONVENTION

Notable Assembly at St. Basil ---Speeches by Clergy and Members of Parliament.

Edmundston, N. B., Aug. 19 (Special).—A large number of Acadians have assembled here in national convention. It is three years since a similar gathering was held at Caraquet. Those here now are from all sections of the maritime provinces. An excursion train with 300 or 400 on board, arrived from Gibson this afternoon.

The rain, which fell during the forenoon and forenoon, prevented the out of door meeting which had been planned. Instead meetings were held in the church, and in the evening there was a great open air meeting in the convent grounds.

There is a big gathering of people here from the surrounding country to welcome the visitors and the houses in the town are gaily decorated. On arrival of the train everybody turned out to greet the newcomers and a number of hymns were sung. It had been intended to open the convention this afternoon with an open air meeting but, owing to the rain, this was held in the St. Basil church.

The weather cleared in the evening and there were fire works and bonfires in different places. The grounds of the convent, where the open air meeting was held, were brilliantly illuminated. MARITIME UNION

Nearly a century and a quarter have passed since Nova Brunswick parted company from Nova Scotia and set up housekeeping for itself.

With the rapidly increasing population of the western provinces, the representation of Nova Scotia, New Brunswick and Prince Edward Island in the federal parliament will be reduced to an extent that we cannot estimate and we will not be worthy of those who have gone before us and who have laid broad and deep the foundations of Canada's greatness.

Halifax Man who Breaks out of Houlton Jail a Month ago.

Fort Fairfield, Aug. 19.—Saturday night Officers Ozime Bell and M. C. Pond captured Joe Murphy, who escaped from Houlton jail four weeks ago. The fellow was making himself very disagreeable and causing considerable uneasiness in the Chambers neighborhood in this town, contiguous to the boundary line. Alarm was given by telephone and the officers hurried to the house, arriving there at 10 p.m. and finding Murphy crouching under a table. He was quickly put in irons and accompanied the constables to the village and placed in the lockup. Monday he was taken back to Houlton jail where a dose of the King's English was administered.

Getting Ready Voters' Lists

Ottawa, Aug. 19.—Under the compromise act of last session whereby provision is made for the direct preparation of federal voters' lists in the unorganized districts of Ontario, boards of registration have been formed in Algona, Nipissing, Muskoka and Thunder Bay and Rainy River. These boards consist of the senior judge of the district and two other judges selected by him. The board names a body of enumerators to prepare the lists in sections without municipal organization.

In the case of Muskoka, the judges have named two enumerators, who probably a still greater number will be appointed for Thunder Bay and Rainy River. The enumerators are being instructed to proceed at once with the preparation of their lists, and they are expected to be ready for the King's English in about six or eight weeks at the latest.

A clause in the act provides that the governor-in-council may confer upon each enumerator any powers necessary for the discharge of his duties. Just what this means is not quite clear, nor, so far as we know, is it the government intention to interfere in any way with the appointments made by the judges or to invest them with any particular authority.

THE MARITIME BOARD OF TRADE

Would Prohibit Export of Pulpwood—Chatham and the Fast Line.

Halifax, Aug. 19.—The maritime board of trade held its opening session at 2.30 p.m. today. It was the largest attendance in the board's history. Addresses of welcome were given by Lieut.-Governor Fraser, Mayor Crosby, President Bell of the maritime board, and President Faulkner of the Halifax board.

Governor Fraser spoke of the great value of honesty in business and advised the members not to fear honest competition. The lower provinces, he said, afforded as good opportunities as the United States for honest business.

Mayor Crosby extended the welcome of the city to the delegates. President Faulkner expressed the pleasure of the Halifax board in entertaining the maritime board. President Bell of the maritime board referred in his report to many questions of the day. He pointed out that the trade of the maritime provinces amounted to \$875 per annum for a family of five. The need of cheap power, better roads, technical education, tourist trade, steel ship building, the P.E. Island tunnel, a fast Atlantic service and greater railway facilities were some of the matters touched upon in his address.

An unanimous resolution was passed approving of a direct line of the I.C.R. from Grand Lake to Dartmouth, thus shortening the route to the port of Halifax by nine miles.

W. B. Snowball, of Chatham, brought the claims of Chatham as a terminus of the fast Atlantic service to the attention of the board.

A resolution advocating the prohibition of the exportation of pulp wood from Canada was passed.

The meeting adjourned till Thursday morning.

HELPS FOR THE HOUSEKEEPER

During the warm months there are many times when just two or three olives are used for dressing a sandwich filling, or for some fancy sauce. After the olives which are needed have been removed, fill the bottle with a good quality of olive oil. The contents will be kept in a good condition for weeks.

A good scouring powder can be made at home by mixing equal parts of powdered pumice stone and some good soap powder. Put in a shallow bowl and set in a convenient spot. It will be found easy to use and will give good results.

To make hose supporters save the buckles and fasteners of old ones and buy new elastic at 10 cents a yard. They will wear very well and the price of a new pair will be saved.

If no patient leather shoe polish is at hand, dip a piece of cloth in sweet milk and rub over the leather, then polish with a dry cloth. This will preserve the leather and keep it from cracking.

When a quart jar of preserved cherries is opened to make pie the juice is usually strained off. This juice will make a delightfully refreshing drink by adding a quart of water, three tablespoons of sugar and some chopped ice.

Always have a good supply of tissue paper in the kitchen, for by cutting in large pieces and dipping in the soup all traces of grease will be removed.
