SEQUEL TO A WHISKEY CASE

Ingersol, Ont. Men Fined for Assault on Detectives.

BODY OF PRETTY GIRL FOUND IN A RIVER

Believe She Was Slain as Was Grace Brown—Men Sought.

McKeessport, Pa., Sept. 13—A mystery strongly resembling the Chester Gillette-Grace Brown case of three years ago, in New York state, is engaging the police here.

The body of a young girl was found in the Younghighy River, just outside the limits of the city. It was identified as that of Myrtle Markel, who was sixteen years old, and was conceded to be the most beautiful girl in the whole Younghighy Valley.

There were evidences that she met her death for the same reasons that "Billie" Brown did, though it has not yet been determined whether she was slain before she was thrown in the river or was drowned.

Two young men who were particularly attentive to the young girl are away from their home. They are being sought.

Boston, Sept. 11—The prohibition party started its state campaign in Massachusetts today by holding its convention in Faneuil hall, selecting a state ticket and adopting a platform.

The ticket selected was as follows: Governor, Prof. John A. Nichols, of Boston; lieutenant-governor, Ernest R. Kyp, of Holyoke; secretary of state, William G. Morrill, of Malden; treasurer, Daniel E. Perlin, of Worcester; auditor, Charles A. Chase, of Swansea; attorney-general, Henry Dean, of Hyatt Park.
