BIG CHANCES FOR A TRADE WITH CUBA

Direct Monthly Steamship Service Between St. John and Havana Direct Will Go Into Effect on September 1st.

St. John shippers, and farmers and merchants throughout the province will be interested in the announcement that the St. John-Cuba steamship service will be resumed on September 1st. William Thomson & Co., have arranged for the steamship Mantinea to go on the route then and to operate a monthly service direct from St. John to Havana, Cuba. The Mantinea is a much larger steamer than the Talisman, which was formerly on this service and she will therefore be able to carry larger cargoes. She will also give a monthly service instead of the bi-weekly service given by the Talisman. The first trip will be made from St. John about the first of September.

Dr. E. S. Kirkpatrick, Canadian trade commissioner to Cuba, who went to the island a short time ago to inquire into trade conditions with the object of determining how trade between Canada and Cuba could be increased has written to several of the shippers here and he states that he is strongly convinced of the desirability of having a direct service from Cuba to St. John and he realizes that such a service could not be maintained without governmental assistance. He also says that he intends laying the matter before the government and hopes to see the service established as he is enthusiastic over the possibilities of a service from this province. There is an excellent market in Cuba for potatoes, fish, hay, oats, lumber, etc., and a regular direct service will no doubt give quite an impetus to trade in this province. It is stated that Carleton county alone can ship from 500 to 800 tons of hay a month as well as thousands of bushels of potatoes.

BLAMES PARENTS FOR ACTS OF CHILDREN

Child Problem Can Never be Solved Until Corrective Influences Apply to Parents, Says Buffalo Speaker

Buffalo, N. Y., June 14—Children law breakers, families and neighbors, immigrants and state superintendents, all agreed to view the topics scheduled for discussion at today's session of the conference of charities and correction.

Frank E. Wade, member of the state probation commission of Buffalo, was the first speaker in the section devoted to law breakers. He claimed that most of the offenses of children are due to the faults of parents, and that the child problem can never be solved until corrective influences are also applied to parents. Mr. Wade would give the juvenile courts exclusive jurisdiction in all cases in which children, or parents who contribute to the delinquency of their children are concerned.

Under the topic "Immigrants," Melino O. Erciziani, attorney at law, Italian immigrants, member of the New York immigration commission, delivered an address. He made the sweeping charge that all cases in which immigrants intending to make the United States their home, are discriminated against in American courts. He stated that the United States discriminated between citizens and prospective citizens by classifying the latter as aliens. He stated that American ports are undesirable and that it is not possible to do this, it might be done by a court rather than by summary, arbitrary and non-judicial tribunals or boards of special inquiry. He claims that this discrimination follows the immigrant after he has become a citizen, both in civil and criminal courts.

VERY CAREFUL ON THE POINT OF UNION

Congregational Union of Canada Passes the Question of Church Union Over to its Congregations

Toronto, Ont., June 14—(Special)—The Congregational Union of Canada did not commit itself as a body on the question of church union, but decided by a unanimous vote to pass the scheme of the joint committee on to the various congregations for expression of their opinions.

Rev. W. T. Gunn, general secretary of the Congregational Union of Canada, declared himself in no uncertain tones as opposed to the union on the basis suggested by the joint committee. The Congregational church, he pointed out, has always stood against a creed test, and to accept such a test as the one proposed would be for the Congregational church a decided step back from the liberty that it enjoys at present.

MURDERER IS ELECTROCUTED

Auburn, N. Y., June 14—William Scott was successfully electrocuted in Auburn this morning for the murder of his stepmother near Chamano Lake, a short distance from Norwich in October of 1907. Two shocks were used to kill. The first one was of 1840 volts at 8 1/2 amperes and lasted for 3 seconds beyond a minute and the second one, of full strength was on but ten seconds.

Scott shot his step mother while they were in a wagon together on a trip, the ostensible purpose of which Scott said was to purchase a stove. The body was thrown into some brush in a wooded part of the country and it was not found until Scott, under arrest on suspicion for murder led officials to the place several days later.

A HOUSE BURNED AT JERUSALEM SATURDAY

Robert Barnett's Building and General Store Was Completely Destroyed—Family Had Narrow Escape.

Word was received this morning from Oak Point of a disastrous fire at Jerusalem on Saturday, when the combined dwelling and general store of Robert Barnett was completely destroyed. The fire was discovered about six o'clock in the morning in the outside kitchen of the house and is thought to have been caused by a defective stove pipe. Mr. Barnett and his family were sleeping at the time, the other members of the family being in bed. The alarm was given and all the inmates escaped safely, though two of the children had to get out in their night clothes. The neighbors hastened to the scene and assisted in saving some of the furniture and goods from the store, but considerable was burned.

A storehouse alongside was saved from the flames after a hard fight. The loss is estimated at something over a thousand dollars, with no insurance.

LIGHTNING STRUCK STEEPLE OF CHURCH

Holy Cross Catholic Church at Green Bay, Wisconsin, Struck During Mass—One Killed, Sixteen Hurt.

Green Bay, Wis., June 14—Lightning struck the steeple of the Holy Cross Catholic church at Bay Settlement during mass yesterday and killed Edward Duchesne, 20 years old, and shocked and injured sixteen other persons, two of whom may not survive. Panic prevailed for several minutes after the bolt struck. It was some time before Father Mickers could quiet the excited congregation of more than 200 persons.

Ontario flour took another jump in price this morning. For the first time in the history of the flour market Manitoba and Ontario flour are selling at the same price. The Ontario brands went up 15 cents and are now selling at 740 per barrel, retail, the same as Manitoba.

VERY CAREFUL ON THE POINT OF UNION

The only criminal case on the docket of the June sitting of the circuit court which opens tomorrow and at which Judge J. H. Barry will make his debut as the presiding judge will be that of the King vs. Dennis Sullivan, for injuring Patrolman Ira Perry on Thursday afternoon on Mill street with a pocket knife while under arrest for intoxication. Sullivan will probably be committed for trial this afternoon.

HIS TRAIN KILLED THREE IN AS MANY DAYS

Conductor Gannon's Opinion as to Recurrence of Railway Accidents Was Speedily Verified.

Montreal, June 14—(Special)—While discussing a wreck which happened at Three Rivers last Thursday, and in which Pierre Caron, his engineer was killed, Dan Gannon, conductor in charge of the Laurentian Mountains Express, Saturday, gave it as his belief that wrecks always come in threes.

He little dreamt that this would come true the same day as he uttered his opinion, but such is destiny. When nearing St. Rose, he advised two passengers, E. Paquette and his son Eudie, who had tickets for St. Therese that his train would not stop there. In spite of this, however, the two passengers stayed on board, and when nearing St. Therese both jumped clear of the track and both his legs were severed. He died soon afterwards. The older man was seriously injured.

This made the second victim, and before the train had gone another dozen miles, and while nearing St. Jerome his third victim in three days was a little girl named Eugenie Houle, aged 22 months, and daughter of F. X. Houle.

NEVER AGAIN WITH PRESENT RULES HE SAYS

Sir Thomas Lipton Declares He Will Not Challenge for America's Cup Until Conditions Are Changed.

Belfast, June 14—In view of the renewal of the rumors that he was preparing again to challenge for the America's cup, Sir Thomas Lipton in an interview today, made it clear that he had no intention of competing under the present conditions.

No man will build a boat to sail under conditions that are or should be past," Sir Thomas said. "I am always willing to give the Americans the advantage of their own universal rule under which they have had experience in building and sailing, and I am ready to challenge thereunder. But I will never try again under the rule of fifty-six years ago. If I challenged under the international rules governing Europe they would say a 'pull'."

TAKING A LAST LOOK AT CHICAGO'S SIGHTS

How Chicago's ex-Judge Spent His Last Hours of Liberty.

CHICAGO, June 14—Former Judge Abner Smith, who probably will be taken to Joliet penitentiary tomorrow to begin his sentence for bank wrecking, spent many hours yesterday riding through the parks of the city and visiting scenes he may never see again. Sheriff Strassheim has arranged to take charge of the former judge at midnight when his reprieve expires.

PLEASURE SEEKERS KILLED ON SUNDAY

Rochester, N. Y., June 14—Three persons were drowned near Lake Ontario Beach resorts yesterday, and one was killed at an amusement park. The first victim was John Diemer, 24 years old, who, clad in heavy rubber boots and a rubber coat, tried to stand up in a canoe. The canoe overturned, and Diemer was drowned.

James Perth, 15 years old, while walking on a pier, was seized with an epileptic fit, fell into the water and was drowned.

An unknown man fell off a pier at Sumnerville and was dead when life savers reached him.

CHURCH PARADE ON SUNDAY NEXT

Whole Strength of Militia Organizations and Cadet Corps Will Hold Inspection and Church Parade.

The annual military church parade of the various local militia companies will take place next Sunday afternoon, June 20th, at 3 o'clock. The troops will be formed up in the following order under command of Lieut. Wedderburn, 8th Hussars, with major McAvity, 62nd Regiment, as Brigade Major: R. O. and R. L. 3rd Regiment, C. G. A. S. A. Veterans, No. 7 Co., C. A. S. C. Ordinance Corps. No. 8 Field Ambulance. St. Stephen's St. Andrew's, St. Luke's, Church Cadets. The local bodies of troops will be inspected at 3 p.m., by Col. Geo. Rolt White, who will then assume command. During the inspection the masses of the 1st Regiment, C. G. A., and 62nd Regiment will play an inspection march under the direction of the senior bandmaster. After the inspection on the brigade parade grounds, the troops will march off in four, by successive companies from the right. The militia service at 4 p.m., in Trinity Church.

The route of march has been decided on as follows:

From parade grounds to Carmarthen, thence to Broad, Charlotte, King and German streets to Trinity Church. After the service has been held, the troops will march off under command of Lieut. Col. Wedderburn, 8th Hussars, proceeding by way of Germain, Union and Charlotte streets to King Square, where they will be reviewed by the D. O. C. and staff, after which they will march to the parade grounds, where they will be dismissed.

Laxton and his wife were married in Nova Scotia 27 years ago. She also comes from Tattamagouche. Hay, the husband of the defendant, is a grand army veteran. He has been married twice. Mrs. Laxton lives in the same house with the Hays here. Both the Hays and Laxtons have grown and married children. For ten years Laxton and his wife have not lived together, but court testimony shows that he has contributed to her support, and to that of her children who reside with her. Hay testified that he knew that his wife was employed by Laxton.

I. C. R. HEADS ARE IN THE CITY TODAY

They Inspected Terminals, Met Supt. Downie and Premier Hazen and Left For Fredericton This Afternoon

Messrs. David Pottinger, E. Tiffin and F. P. Brady, of the I. C. R. commission arrived in this city this morning from Moncton, joining M. J. Butler, the other commissioner, who arrived Saturday. Messrs. Tiffin and Brady, with J. T. Hallisey, superintendent of the St. John-Halifax division, W. B. McKenzie, chief engineer of maintenance, and L. R. Ross, terminal agent, inspected the yard, new island yard and round house, freight sheds and the Long wharf and sheds in vicinity. Speaking afterwards, Mr. Tiffin said that they found everything in excellent shape and there were no changes that would be made that he knew of at the present time.

Mr. Tiffin and Mr. Brady had a conference with Wm. Downie, general superintendent of the Atlantic division C. P. R., and W. B. Howard, D. P. A., and discussed matters in connection with the I. C. R. summer table of contents with C. P. R. trains. Mr. Tiffin says that the only change that will be made from last year's summer schedule will be the consolidation of the C. P. R. train from Montreal, leaving here at noon for Halifax with the Ocean Limited at Moncton and the same change in leaving Halifax. The change will effect a saving in running expenses, as it will do away with a train between Moncton and Halifax.

Mr. Butler and Mr. Pottinger had a conference with Premier Hazen this morning with reference to the I. C. R. claim against the Central Railway of \$40,000 for rails. It was arranged, Mr. Butler announced after the meeting, to take the matter up at Ottawa at a later date. The commissioners leave by special train at 3 o'clock this afternoon for Fredericton.

WILL NOT CHANGE THE WATER RATES

Water and Sewerage Board Met This Morning and Talked a Great Deal But Made No Changes

A special meeting of the water and sewerage board was held this morning to discuss the matter of revising the water rates so that manufacturers could have an abatement in their assessment. The proposition was made that a reduction from one-half to one-quarter per cent on stocks-in-trade be made but this was not considered possible under existing conditions. The comptroller stated that it would be impossible to make any such reduction without upsetting completely the assessment as already made up. If any change was made, it would mean simply transferring the charge from one class of ratepayers to another.

The matter was discussed at length and it was suggested that a reduction of one-eighth might be made, changing the charge from one-half to three-eighths of one per cent. It was finally, however, left to the council to decide the matter.

The proposition of Ald. Kelley to make a fixed charge on orphanages and other charitable institutions of \$1 a year, was brought up in a resolution and was defeated. So far as the meeting is concerned there will be no change in the assessment as already submitted to the council. All the members of the board were present, as well as the engineer, comptroller and common clerk.

LOST EIGHT MEN IN A HEAVY FOG

Fishing Schooner Nettie Franklin Arrived at Boston With Eight Members of Her Crew Missing

Boston, June 14—With eight of her crew missing, the fishing schooner Nettie Franklin arrived in port early today after a fruitless two days' search for the men. The eight men were out in their dories hauling the trawls on Thursday morning when a heavy fog shut in. Captain Antonio P. The Franklin remained on the fishing grounds cruising around in an effort to pick up the missing members of her crew until Saturday morning, when the search was given up and the vessel was headed for Boston. PROSECUTING THE "FAITH CURE" PEOPLE

First Prosecution of Christian Scientists in Manitoba--Child Died from Pneumonia, but No Doctor Was Called.

Winnipeg, Man., June 14—(Special)—The first prosecution of a Christian Scientist in Manitoba for failing to summon a physician in a case of serious illness, has been instituted by the attorney general, following the death of a child of J. H. Williams, of Virde, from pneumonia. No doctor was called to attend the child, who had been suffering from pneumonia for some time, and who developed the fatal disease. Two Christian Science practitioners, Mrs. McDougall and Mrs. Sprague, are under surveillance, and Mr. Williams has been arrested. Mr. Williams is charged with causing the death of the child, which is equivalent to manslaughter.
