Our devoted gratitude is due to the Supreme Being for having graciously continued to our beloved country, through the vicissitudes of another year, the blessings of peace, plenty and peace.

When I entered upon the discharge of my official duties in March, 1845, at the distribution of the public revenues, the public treasury was empty.

Nearly twenty-eight millions of dollars of the public moneys, in pursuance of the provisions of the Constitution, were deposited in the Treasury on the 1st of January, 1845, and of that year.

There occurred a general suspension of specie payments, by the banks, including, with very few exceptions, those which the public moneys were deposited, and upon whose fidelity the Government had uniformly made itself dependent for the redemption of its public securities.

This suspension, and access, and which were aggravated by its occurrence, made, to a great extent, unavailable the principal part of the public moneys then on hand; suspended the collection of the public revenues, and, by the same token, greatly reduced the revenue arising from customs and the public lands.

These effects have continued, in various degrees, to the present period, and in addition to the decrease in revenue thus produced, two and a half millions of dollars have been relinquished by a biennial reduction of the public moneys.

It affords me, however, great pleasure to be able to say, that, from the commencement of this period to the present day, every demand upon the Government has been promptly and abundantly met.
