CANADA'S SEED INDUSTRY

The seed growing industry in Canada has been gradually developed and improved during the period of the past thirty years, a report recently prepared by the Feed Branch states, it now embraces the production and improvement of approved varieties of cereals of pedigreed stock, the production of forage crop seeds, and the production of field root, garden vegetable, and flower seeds. It is estimated that in 1931 3,710 farms were producing seed crops subject to federal inspection, and that around 12,000 persons were engaged in the production and marketing of the improved seed.

TRIBUTE TO REV. GORDON PRINGLE

(Continued from Page One)

MacDonald at Fredericton; Wm. Ross at Prince William; MacLean at Harvey; Gunn at St. Andrews; J. Anderson at St. Stephen; L. A. MacNeill in Saint Andrew's Church, Saint John; James Ross, Woodstock; J. A. Sutherland, Sussex; J. Burgess, Carleton; Vans, St. George; J. Hawley; J. S. Mullen, Stanley; D. Fiske, Florenceville; A. J. Lods, Grand Falls.

"Of these nearly all have passed away. Mr. Pringle is the only one in active service. Dr. James Ross, so long Supt. of Missions, has retired, and is living in Halifax, and Mr. Clark in Truro, Dr. J. A. Sutherland in Halifax, and Dr. Robinson in New York.

"In this same year, November 13, 1892, he began the first ministry in the congregation of Kincardine and Kintore. It is easy to think of him as pastor of this congregation since that date, for while his body was in Lorneville and Grand Bay for a period of three years, there is no doubt that his heart was in Kincardine all the while. Twice he was called back in that time and in 1896 he responded to the call of his first love and ever since has been its minister.

"Mr. Pringle has been an excellent and fearless preacher of the Word, a diligent and faithful pastor, and among his brethren in the Presbytery, with his sanity of judgment, clearness of vision and wisdom in council, he stands high—a brother beloved. He is retiring in disposition and so has not thrust himself into the limelight. The story is told that on one occasion he was elected Moderator of Saint John Presbytery, and discharged the duties of his office so efficiently that his brethren were determined that year to elect him to the office of Moderator of Synod. I need only state, however, that when the time came, Mr. Pringle was not to be found. Since the Union, after which the Presbytery of Woodstock came into existence, Mr. Pringle served for a year as its chairman, and there are those whose names are on its roll call today, willing to testify to the efficiency with which he discharged the duties of his office.

"It is not for me to dwell at length on the influence of Mr. Pringle on the lives of this congregation, or on the lives of those influenced by him, which in their turn have gone far afield—making a most valuable contribution to other churches and communities all over the country. Who can estimate such an influence? There is, too, the influence of the man as seen in his own family. Whether due to his clearness of vision to which reference has already been made, he anticipated by several years the Union of the Churches. He married Harriet LePage, daughter of Rev. A. E. LePage, in 1898, at Woodstock, and to them were born four daughters and one son. The son, as we well remember, was licensed to preach last May and was ordained at the meeting of Conference in June, thus forging another link in the chain of true Apostolic succession. The daughters are all graduates of the Provincial Normal School and have contributed or still are making a valuable contribution to the educational life of the Province. Mrs. Pringle performed well the duties of wife and mother, for while today she is not with us in body—for God took her—she is with us in spirit, and her hands wait for that of her beloved beyond earth's fret, till out of night he wanders home to her. And with the eye of faith we see her hands today—beautiful hands—beckoning hands, calling the dear ones to heavenly lands—and they are responding.

"In observing the fortieth anniversary of Mr. Pringle's ordination Woodstock Presbytery hereby desires to place on record its deep sense of gratitude to God for his long and useful ministry, nearly all of which he has spent in the one congregation of Kincardine; its high appreciation of his worth and work as a man and a preacher; of his clearness of vision, sanity of judgment, and wisdom in council, as well as his characteristic Scottish humour. Presbytery hereby congratulates minister and people on the long period during which they have been successful

co-workers with God in this portion of His vineyard, and prays that our Heavenly Father may long spare Mr. Pringle to be their leader in spiritual things, and in the quiet evening of his life, he may more and more realize the preciousness of divine promises and the sustaining power of the Gospel which he himself has preached; that many souls may yet be given him as a reward for his labours until the dawning of the day when he will hear the "Well done, good and faithful servant."
